Revista Colombiana de Anestesiología (Colombian Journal of Anesthesiology) is the official publication of *Sociedad Colombiana de Anestesiología y Reanimación, S.C.A.R.E.* (Colombian Society of Anesthesiology – S.C.A.R.E.). Since its inception in 1972, this quarterly publication seeks to publish and disseminate knowledge associated with the specialty and its related areas, including Perioperative Medicine, Intensive Care, Pain Medicine, Palliative Care, Cardiovascular Surgery, Clinical Practice, Pediatric Surgery, Neurosurgery, Trauma, Patient Safety, Healthcare Quality, basic and applied clinical research (*translational research*), education, history, healthcare technologies and reviews.

General Rules

Transparency Declaration

Revista Colombiana de Anestesiología endorses the transparency declaration by the principal author of the paper. The form will be completed and sent with the manuscript. Ethics in publishing

Human and animal rights

If the work involves the use of animal or human subjects, the author should ensure that the work described has been carried out in accordance with The Code of Ethics of the World Medical Association (Declaration of Helsinki) for experiments involving humans <http://www.wma.net/en/30publications/10policies/b3/index.html>; EU Directive 2010/63/EU for animal experiments http://ec.europa.eu/environment/chemicals/lab_animals/legislation_en.htm; Uniform Requirements for manuscripts submitted to Biomedical journals <http://www.icmje.org>. Authors should include a statement in the manuscript that informed consent was obtained for experimentation with human subjects. The privacy rights of human subjects must always be observed.

Conflict of Interest disclosure

In this section, which is mandatory for all papers, the authors must state whether there are any conflicts of interest or not. If yes, a detailed description is required. It is important for the journal that the author understands what is meant by conflict of interest in relation to scientific and scholarly publications. For this reason, we invite you to learn more about this topic by Reading the article entitled *Conflictos de intereses en revistas médicas* (<http://dx.doi.org/10.1016/j.rca.2013.06.006>). Submission declaration and verification

Submission of an article implies that the work described has not been published previously (except in the form of an abstract or as part of a published lecture or academic thesis or as an electronic preprint, see <http://www.elsevier.com/sharingpolicy>), that it is not under consideration for publication elsewhere, that its publication is approved by all authors and tacitly or explicitly by the responsible authorities where the work was carried out, and that, if accepted, it will not be published elsewhere in the same form, in English or in any

other language, including electronically without the written consent of the copyright-holder. To verify originality, your article may be checked by the originality detection service CrossCheck <http://www.elsevier.com/editors/plagdetect>.

Contributors

Each author is required to declare his or her individual contribution to the article: all authors must have materially participated in the research and/or article preparation, so roles for all authors should be described. The statement that all authors have approved the final article should be true and included in the disclosure.

Authorship Criteria

Pursuant to the uniform requirements, an author will be considered as such provided he/she has had a substantial participation in the planning of the work or article, the concept and design, as well as in data gathering, analysis or interpretation.

In order to comply with this requirement, the paper must be submitted together with a letter signed by all the authors, stating clearly that the paper has been read and approved by all and that it has not been published, in full or in part, in any other printed or digital publication, except for abstracts or proceedings of presentations in congresses.

Changes to authorship

This policy concerns the addition, deletion, or rearrangement of author names in the authorship of accepted manuscripts:

Before the accepted manuscript is published in an online issue: Requests to add or remove an author, or to rearrange the author names, must be sent to the Journal Manager from the corresponding author of the accepted manuscript and must include: (a) the reason the name should be added or removed, or the author names rearranged and (b) written confirmation (e-mail, fax, letter) from all authors that they agree with the addition, removal or rearrangement. In the case of addition or removal of authors, this includes confirmation from the author being added or removed. Requests that are not sent by the corresponding author will be forwarded by the Journal Manager to the corresponding author, who must follow the procedure as described above. Note that: (1) Journal Managers will inform the Journal Editors of any such requests and (2) publication of the accepted manuscript in an online issue is suspended until authorship has been agreed.

After the accepted manuscript is published in an online issue: Any requests to add, delete, or rearrange author names in an article published in an online issue will follow the same policies as noted above and result in a corrigendum.

Clinical trial results

In line with the position of the International Committee of Medical Journal Editors, the journal will not consider results posted in the same clinical trials registry in which primary registration resides to be prior publication if the results posted are presented in the form of a

brief structured (less than 500 words) abstract or table. However, divulging results in other circumstances (e.g., investors' meetings) is discouraged and may jeopardise consideration of the manuscript. Authors should fully disclose all posting in registries of results of the same or closely related work.

Registration of clinical trials

Registration in a public trials registry is a condition for publication of clinical trials in this journal in accordance with International Committee of Medical Journal Editors (ICMJE, <http://www.icmje.org>) recommendations. Trials must register at or before the onset of patient enrolment. The clinical trial registration number should be included at the end of the abstract of the article. A clinical trial is defined as any research study that prospectively assigns human participants or groups of humans to one or more health-related interventions to evaluate the effects of health outcomes. Health-related interventions include any intervention used to modify a biomedical or health-related outcome (for example drugs, surgical procedures, devices, behavioural treatments, dietary interventions, and process-of-care changes). Health outcomes include any biomedical or health-related measures obtained in patients or participants, including pharmacokinetic measures and adverse events. Purely observational studies (those in which the assignment of the medical intervention is not at the discretion of the investigator) will not require registration.

Transfer of rights

The author must agree to the transfer of intellectual property rights to the Colombian Society of Anesthesiology (S.C.A.R.E.). This step must be completed after the manuscript approval.

All articles published will be immediately and permanently free for everyone to read and download. Permitted reuse is defined by the Creative Commons (CC BY-NC-ND). For non-commercial purposes, lets others distribute and copy the article, and to include in a collective work (such as an anthology), as long as they credit the author(s) and provided they do not alter or modify the article.

Open Access Publication Fee

No fee is payable by the author as publishing and submission costs are covered by the Society.

Author rights

Upon acceptance of an article, authors will be asked to complete a 'Journal Publishing Agreement'. Acceptance of the agreement will ensure the widest possible dissemination of information.

Copyright will be transferred to the Society if the manuscript is accepted for publication. Permission of the Society is required for resale or distribution outside the institution and for all other derivative works, including compilations and translations.

Source of Funding

In this section, which is mandatory for all papers, the authors must state whether there are any sources of funding. You are requested to identify who provided financial support for the conduct of the research and/or preparation of the article and to briefly describe the role of the sponsor(s), if any, in study design; in the collection, analysis and interpretation of data; in the writing of the report; and in the decision to submit the article for publication. If the funding source(s) had no such involvement then this should be stated.

Informed consent and patient details

Studies on patients or volunteers require ethics committee approval and informed consent, which should be documented in the paper. Appropriate consents, permissions and releases must be obtained where an author wishes to include case details or other personal information or images of patients and any other individuals in an Elsevier publication. Written consents must be retained by the author and copies of the consents or evidence that such consents have been obtained must be provided to Elsevier on request. Unless you have written permission from the patient (or, where applicable, the next of kin), the personal details of any patient included in any part of the article and in any supplementary materials (including all illustrations and videos) must be removed before submission.

Peer review

This journal operates a double blind review process. All contributions will be initially assessed by the editor for suitability for the journal. Papers deemed suitable are then sent to a minimum of two independent experts reviewers to assess the scientific quality of the paper. The Editor is responsible for the final decision regarding acceptance or rejection of articles. Uniform requirements for manuscripts submitted to biomedical journals

Revista Colombiana de Anestesiología (Colombian Journal of Anesthesiology) abides by the Uniform Requirements for Manuscripts Submitted to Biomedical Journals of the International Committee of Medical Journal Editors, published in *The New England Journal of Medicine*, 1997; 336:309-15 <http://www.icmje.org>

Publication Classification

Revista Colombiana de Anestesiología (Colombian Journal of Anesthesiology) publishes manuscripts that adjust to the following typology. The parameter on the number of words, references included, is mandatory.

1. **Editorials:** max. 2000 words
2. **Clinical, experimental, basic and applied research (original paper):** max. 4000 words
3. **Health education research (original paper):** max. 4000 words
4. **Systematic Review articles (original paper):** max. 7500 (including at least 50 references)
5. **Non-systematic reviews (original paper):** 4000 words (including at least 50 references)
6. **Evidence-based clinical practice guidelines (original paper):** max. 7500 words
7. **Management guidelines, protocols and consensus (original paper):** max. 5000 words

8. **Reflection articles derived from research (original paper):** max. 4000 words
9. **Reflection articles not derived from research:** 2000 words
10. **Technology update and innovation (original paper):** max. 4000 words
11. **Continuing medical education articles:** 2000 words
12. **History of Medicine, the specialty and related areas:** 2000 words
13. **Case report:** 2000 words
14. **Letters to the Editor:** 250 words
15. **Reviews:** 500 words

Manuscript submissions

The editorial management of the Journal is done through the Elsevier EES. This means that the whole process of reception, review, edition and publication is done at the manager site <http://ees.elsevier.com/rca/> which is linked to the Journal's website <http://www.revolanest.com.co>

Preparation of manuscripts

The first stage of the process depends on the care and preparation of the documents that you submit to the Journal. For this reason, we encourage you to follow carefully each of the steps listed below:

Authors

The first page must contain a) the title of the article (Spanish or English); b) the names and surnames of each author, including their highest academic degree (MD, PhD, Master), academic rank (tenured professor, associate, assistant, instructor, graduate MD student), and the institution, department or section to which they belong; postal address; e-mail and contact telephone number.

Title

Remember that the title is your first contact with the reviewer and your readers; we suggest that you make it clear and concise. It must be written in Spanish and English and contain key words that will contribute to the visibility of your publication when bibliographic searches and indexations are made. We recommend that you avoid subtitles and the use of references in the title and the subtitles.

Abstracts

The abstracts must be written in the original language of the manuscript and have no more than 250 words. For original papers, the abstract must be structured to include the following sections: Introduction, Objectives, Materials and Methods, Results, and Conclusions. We suggest that you emphasize those things that are new and original about your work. You must not use abbreviations or references.

How to cite our Journal

To cite articles from *Revista Colombiana de Anestesiología* (Colombian Journal of Anesthesiology) please bear in mind that the official abbreviation is Rev. Colomb. Anestesiol.

Key Words

The terms required in this section are five to eight words or short phrases. Since these will allow your manuscript to appear among the search results, we recommend that they relate directly to the manuscript and that they are also validated by the *Index Medicus (Medical Subject Headings, MeSH)* in www.nlm.nih.gov/mesh/meshhome.html or by descriptors in *Ciencias de la Salud (DeCS)* of BIREME (<http://decs.bvs.br/E/homepagee.htm>). In cases of unknown terms or terms that have appeared recently and are not included in MeSH or DeCS, but which are meaningful for the study, we suggest that you highlight them and justify their use.

Graphic material and Multi-media

All this material must be included at the end of the manuscript, in separate pages. Tables, images, graphs, surveys, guidelines and

others must be mentioned in the text and numbered in accordance with the order in which they appear. Likewise, you need to mention the source of the material, even if it results from the submitted study. If the material belongs to a third party, you need to attach the license for use given by the holder of the property rights. Tables must not use vertical or horizontal lines; each column must have the appropriate heading, and headings should not include clarification notes or references; if needed, these must be included at the bottom of the table.

Images must be submitted in bitmap (*.bmp), GIF (*.gif), JPEG (*.jpg), TIFF (*.tif) formats, with a minimum 300 dpi resolution. For graphs, avoid 2D circular design (pie charts). If you include photographs of individuals, you must submit the authorization to publish them. Considering that the Journal is also on several digital platforms, we suggest the use of multimedia tools that support your studies, in order to enhance the publication.

Bibliographic references

The Journal uses the Vancouver style, according to which references are numbered as the authors are cited, using Arabic numerals in parenthesis. Accuracy in terms of punctuation and abbreviations in journals is of the utmost importance; for this reason, we suggest reviewing the *Index Medicus* (<http://www.nlm.nih.gov/tsd/serials/lji.html>) in order to avoid mistakes. The editorial policy requires citing at least one national or Latin-American author or journal, and we also recommend not to reference unpublished documents. If it needs to be done, the DOI must be inserted. If in doubt about citation, we recommend that you read carefully the information in <http://www.ncbi.nlm.nih.gov/books/NBK7256/> where you will find examples for each of the materials or contents.

Writing considerations

When writing scholarly and scientific papers, you need to use parameters that will allow you to use the "same language", irrespective of idiomatic differences. Consequently, we would like you to write each paragraph using clear, concise and coherent statements, by following a simple structure or syntax (subject-verb-object); avoid the use of gerunds and inserts in parenthesis. We also recommend that you read the following rules for specific words and terms:

Measurement Units

After acceptance

Use of the Digital Object Identifier

The Digital Object Identifier (DOI) may be used to cite and link to electronic documents. The DOI consists of a unique alpha-numeric character string which is assigned to a document by the publisher upon the initial electronic publication. The assigned DOI never changes. Therefore, it is an ideal medium for citing a document, particularly 'Articles in press' because they have not yet received their full bibliographic information. Example of a correctly given DOI (in URL format; here an article in the journal *Physics Letters B*): <http://dx.doi.org/10.1016/j.physletb.2010.09.059> When you use a DOI to create links to documents on the web, the DOIs are guaranteed never to change.

Proofs

One set of page proofs (as PDF files) will be sent by e-mail to the corresponding author (if we do not have an e-mail address then paper

proofs will be sent by post) or, a link will be provided in the e-mail so that authors can download the files themselves. Elsevier now provides authors with PDF proofs which can be annotated; for this you will need to download Adobe Reader version 9 (or higher) available free from <http://get.adobe.com/reader>. Instructions on how to annotate PDF files will accompany the proofs (also given online). The exact system requirements are given at the Adobe site: <http://www.adobe.com/products/reader/tech-specs.html>.

If you do not wish to use the PDF annotations function, you may list the corrections (including replies to the Query Form) and return them to Elsevier in an e-mail. Please list your corrections quoting line number. If, for any reason, this is not possible, then mark the corrections and any other comments (including replies to the Query Form) on a printout of your proof and return by fax, or scan the pages and e-mail, or by post. Please use this proof only for checking the typesetting, editing, completeness and correctness of the text, tables and figures. Significant changes to the article as accepted for publication will only be considered at this stage with permission from the Editor. We will do everything possible to get your article published quickly and accurately. It is important to ensure that all corrections are sent back to us in one communication: please check carefully before replying, as inclusion of any subsequent corrections cannot be guaranteed. Proofreading is solely your responsibility.
